- 2) Member will be billed the minimum charge when they have spent less than the minimum during the previous month. Both dues and the minimum are subject to change as approved by Rustic Hills Management, Inc. Payment shall be made to Rustic Hills Country Club.
- 3) The one-time initiation fee is due upon approval of this application. Membership shall not begin until the initiation fee and first month's membership dues are paid in full. Terminated members will be liable for outstanding accounts.
- 4) Membership requires a one year commitment. After your one year commitment has been satisfied, your membership converts to a month-to-month basis. Members can resign from membership after the initial one year commitment by submitting a written resignation to Rustic Hills Management thirty days prior to their membership anniversary month. If the notice of resignation is not received thirty days prior to the anniversary month, the membership will then be rolled over an additional month. Your account must be in good standing and current before resignation can be accepted. Example: A member who joined in the month of May would be required to submit a resignation request by April 1st in order for it to be effective May 1st. If the resignation request is submitted after April 1st, the resignation would then be effective June 1st.
- 5) Both the applicant and his/her spouse shall be jointly liable for all charges under this membership.
- 6) Members specifically agree to indemnify the club, Rustic Hills Management, Inc. and club owners for any and all losses due to purposeful or negligent acts of the member, member's guest or employees, or member's children, including acts occurring as a result of the consumption of alcohol.
- 7) It is the goal of Rustic Hills Country Club to provide a safe and responsible atmosphere for social interaction. By signing the membership contract, members agree that if either they or any of their guests, employees or family members have a problem with alcohol, or habitually drink to excess, that member will inform the club management prior to allowing said person to use any of the club facilities. Any information under this paragraph will be strictly confidential to the bar and management staff of Rustic Hills Country Club, and will be used only to avoid serving alcoholic beverages to such persons.
- 8) Members hereby state that they have received a copy of, read, understand and agree to abide by the rules, regulations, by-laws and policies listed in Rustic Hills Country Club member handbook, and hereby incorporated, word for word, into this contract. Members additionally agree to abide by these rules, regulation, by-laws and policies as they are revised and amended in the future. Any provision to be found invalid will be stricken from the contract, keeping the remainder of the contract legally binding.
- 9) Members agree to pay all accounts when due. Amounts over 30 days overdue will accrue a finance charge of 1.5% each month. Members with accounts 60 days overdue will have their charging privileges suspended (delinquent account), and their account balance will be posted on the club bulletin board until it is current. Members agree to pay all reasonable attorney fees and costs incurred by Rustic Hills Country Club in the event that collection proceedings are undertaken to obtain monies owed to the club.
- 10) By signing this contract, applicants agree that neither Rustic Hills Country Club, Rustic Hills Management, Inc., nor the owners shall be held liable for any personal injury, loss or damage to personal property of any member, guest, employee or family members.
- 11) Membership is subject to approval of a majority of the Board of Directors. The Board reserves the right, subject to a majority vote, to grant individual members exceptions from the deferral of their obligations under this contract based on specific circumstances without affecting in any way the other obligations under this or any other membership contract. By granting such exceptions and deferrals, neither the Board nor the Club waive any rights to enforce the provisions of this contract as written in the future.
