This Agreement is made between the Member(s) listed above and Rustic Hills Management, Inc., an Ohio corporation, which is referred to in this Agreement as Rustic Hills. By applying for membership at Rustic Hills Country Club, I hereby agree to the following:

1. **Application.** Each applicant is subject to approval for membership by Rustic Hills, in its sole and subjective discretion. If my application for membership is approved, then the remaining provisions of this Agreement will be effective and binding.
2. **Membership Categories.** There are 7 membership categories listed above: 'A', 'B', 'C', 'D', 'E', 'F' and 'G'. I am applying for the membership category which I circled above. As long as I remain a member of Rustic Hills, and my account is in good standing, I am entitled to enjoy the rights and privileges for my selected Membership Category. I am also responsible for the dues, fees and other obligations for that Membership Category. Those rights, privileges, dues, fees and responsibilities are listed in the Rustic Hills Country Club Membership Handbook, as it exists now and as it may be amended from time to time by Rustic Hills. I understand that Rustic Hills will provide notice at least 30 days before making any changes to my monthly minimum charge or dues.
3. **Minimum Monthly Charge and Dues.** Rustic Hills thrives on maintaining an active membership. Every member is therefore encouraged to use the facility, and to spend an amount equal to the minimum charge every month. I understand that I am responsible for paying the minimum monthly charge for my Membership Category as listed in the Membership Handbook. If my monthly charge in any given month does not equal or exceed the minimum monthly charge, then I will be responsible for paying the difference for that month. I am also responsible for payment of dues, as set forth in the Membership Handbook.
4. **Initiation Fee.** The one-time initiation fee listed in the Membership Handbook is due upon approval of this application. Membership shall not begin until the initiation fee and first month's membership dues are paid in full.
5. **Term.** The initial Membership term is one year. After the initial term, Membership continues from month to month. A Member may resign after the initial term by providing at least 30 days prior written notice to Rustic Hills. A Member's resignation shall not be effective, and the Member shall continue to accrue monthly charges, until the Member's outstanding account is paid in full. *Example:* A member who joined in May must submit a resignation request by April 1st in order to be effective May 1<sup>st</sup>. If the resignation request is submitted after April 1st, the resignation would be effective June 1st.
6. **Joint and Several Liability.** For married couples, both the applicant and spouse shall be jointly and severally liable for all charges under this Agreement.
7. **Hold Harmless/Indemnification.** I agree to hold harmless and indemnify Rustic Hills, its employees, agents, directors and officers for any and all injury, damage or losses, except as may have been due to the gross negligence of Rustic Hills. I further hold harmless and indemnify Rustic Hills, its employees, agents, directors and officers for any and all injury, damage or losses caused by me, my children, guests or employees.
8. **Alcohol.** It is Rustic Hills' goal to provide a safe and responsible atmosphere for social interaction. I agree that if I or any of my guests, employees or family members have a problem with alcohol, or habitually drink to excess, I will inform Rustic Hills management prior to allowing that person to use any of the club facilities. Any information under this paragraph will be strictly confidential to the bar and management staff of Rustic Hills, and will be used only to avoid serving alcoholic beverages to such persons.
9. **Handbook.** I have received a copy of, read, understand and agree to abide by the rules, regulations, and policies listed in Membership Handbook. I agree to abide by these rules, regulation, and policies as they are revised and amended in the future. The Membership Handbook is incorporated into this Agreement as if fully rewritten herein. Any provision of this Agreement found invalid by a court will be stricken from the Agreement, keeping the remaining terms of the Agreement.
10. **Remedies for Nonpayment.** I agree to pay all accounts when due. I will pay 1.5% monthly interest on all amounts which are overdue by at least 30 days. **I hereby authorize Rustic Hills to charge my credit card listed above for any amounts overdue by at least 60 days.** I will pay all costs, including reasonable attorney's fees, for any action Rustic Hills takes to enforce this Agreement, whether or not legal action is filed. I understand that Rustic Hills reserves the right, in its discretion, to suspend my use of some or all of the club facilities if my account is overdue by at least 60 days. Members with accounts 60 days overdue will have their charging privileges suspended, and their account balance may be posted on the club bulletin board until it is current. Failure of Rustic Hills to exercise any rights or remedies under this Agreement shall not constitute a waiver of future enforcement.
